Item I:

Verification of modified draft MoUs of CUSAT with following institutes/organisations


- i. Indian Institute of Tropical Meteorology (IITM), Pune
- ii. National Institute of Technology (NIT), Calicut
- iii. National Institute of Medium Range Forecasting (NCMRWF), Noida, Uttar Pradesh

The meeting noted that the IQAC Core Committee held on 21/12/2021 recommended to redraft the MoUs with the above institutes as per approved MoU format of the University. The meeting verified the redrafted MoUs with the above organisations forwarded by the Head, Department of Atmospheric Sciences, in detail and following decisions have been taken:

- i. The committee noted that, the Centre /Institute shall be a recognised Research Centre of the University for registering the research scholars and to guide them as per regulation for Ph.D registration and recognition of research guides of the University. As the Indian Institute of Tropical Meteorology (IITM), Pune is not a recognised research Centre of the University, the committee suggested that collaborative

- projects/collaborative programmes, shall be initiated to include the research guideship in Ph.D Programme. The Committee recommended to correct the MoU accordingly.
- ii. The meeting recommended to enter into MoU with National Institute of Technology (NIT), Calicut, Kerala and recommended to approve the draft MoU.
 - iii. The committee noted that, the Centre /Institute shall be a recognised Research Centre of the University for registering the research scholars and to guide them, as per regulation for Ph.D registration and recognition of research guides of the University. As the National Institute of Medium Range Forecasting (NCMRWF), Noida, Uttar Pradesh is not a recognised research Centre of the University, the committee suggested that collaborative projects/collaborative programmes, shall be initiated to include the research guideship in Ph.D Programme. The Committee recommended to correct the MoU accordingly.
