ORDER

The work of installation of 28 exhibition stalls for Shashtrayaan 2018 was entrusted to M/S Events Gandhimathi,Giri Nagar, Kochi vide paper read as (2) above, as per specifications laid down in the tender no.EL/223/2017-18/1129 dated 06/02/18 at a total cost of Rs.1,99,101/-(Rupees One lakh ninety nine thousand one hundred and one only).

Dr.Supriya M.H, Coordinator, Shashtrayaan has informed, vide paper read as (1) above, that 17 numbers of exhibition stalls had been installed additionally (total 45 stalls) as per requirement of various departments/schools/centres. Further, additional items such as system barricade, A/C covering for octonorm panel, extra octonorm tables, ELCB set and generator set etc. had been installed as per requirements came up on 27/02/2018. The excess expenditure incurred in connection with the installation of additional 17 numbers of exhibition stalls and additional items is Rs.1,71,850/- (Rupees One lakh seventy one thousand eight hundred and fifty only).

The meeting of the committee constituted for the conduct of Shashtrayaan 2018 had recommended, vide paper read as (3) above, to increase the number of exhibition stalls from 28 to 50 by considering the requirement of various departments. Similarly the meeting of the committee held on 16/03/2018 has recommended the approval of additional expenditure of Rs.1,71,850/-(Rupees One Lakh seventy one thousand eight hundred and fifty only) incurred in connection with the installation of additional 17 numbers of exhibition stalls and additional items , vide paper read as (4) above.

Considering these, sanction is accorded by the Vice-Chancellor to permit Dr.Supriya M.H, Coordinator, Shashtrayaan & Professor, Dept. of Electronics to pay the additional expenditure incurred in connection with the installation of additional 17 numbers of exhibition stalls and additional items such as system barricade, A/C covering for octonorm panel, extra octonorm tables, ELCB set and generator set etc. to M/s Events Gandhimathi,Giri Nagar, Kochi.
