 - (ii) Review of proposals /applications for visit to areas classified under ASPA/ ASMA with due consideration of the ATCM guidelines and accord in time approvals to PI's/ Participating Members of the Indian Scientific Expeditions to Antarctica;
 - (iii) Assist / advise NCPOR on issues of environmental management of Indian Stations in Antarctica, following CEP/ ATCM guidelines.
- 4. The Committee shall submit recommendations on the mandate at para 3(i) above by **14 March 2022**.
- 5. Travel and logistic expenses for the purpose would be borne by NCPOR. Sitting fees to the external members would be paid in accordance with Department of Expenditure, Ministry of Finance O.M. 19047/10/2016-E-IV dated 12.04.2017. Secretarial Assistance to the Committee shall be provided by Environmental Impact Assessment Section, NCPOR.
